On October 20, 2006, the Public Utilities Commission (Commission) received an Application from Sprint Communications Company L.P. (Sprint) for authority to provide local exchange services in certain rural areas served by Brookings Municipal Utilities d/b/a Swiftel Communications (Swiftel).

On October 26, 2006, the Commission electronically transmitted notice of the filing and the intervention deadline of November 10, 2006, to interested individuals and entities. South Dakota Telecommunications Association (SDTA) filed to intervene on November 7, 2006. Swiftel filed to intervene on November 9, 2006. Swiftel was granted intervention. SDTA was granted intervention subject to certain restrictions.

The parties have agreed to the following procedural schedule:

A hearing will be held on this matter beginning at 8:30 A.M. on June 28, 2007, in Room 412 of the State Capitol Building, 500 East Capitol, Pierre, South Dakota.

The Commission has jurisdiction in this matter pursuant to SDCL Chapters 1-26 and 49-31, specifically SDCL 49-31-69 through 49-31-75, inclusive. The Commission may rely upon any or all of these or other laws of this state in making its determination. The issue to be determined by the Commission is whether Sprint will be granted authority to provide local exchange services in certain rural areas served by Swiftel.

The hearing will be an adversary proceeding conducted pursuant to SDCL Chapter 1-26. All persons testifying will be subject to cross-examination by the parties. All parties have the right to be present and to be represented by an attorney. These rights and other due process rights may be forfeited if not exercised at the hearing. If a party or its representative fails to appear at the time and place set for the hearing, the Final Decision will be based solely on the testimony and evidence provided, if any, during the hearing or a Final Decision may be issued by default pursuant to SDCL 1-26-20. After the hearing, the Commission will consider all evidence and testimony that was presented at the hearing. The Commission will then enter Findings of Fact, Conclusions of Law, and a Final Decision regarding this matter. As a result of the hearing, the Commission will determine whether to grant Sprint authority to provide local exchange services in certain rural areas served by Swiftel. The Commission's Final Decision may be appealed by the parties as provided by law.

It is therefore

ORDERED, that the parties shall follow the procedural schedule as set forth above; and it is

FURTHER ORDERED, that a hearing shall be held at the time and place specified above on the issue set forth above.
