On February 24, 2009, the Public Utilities Commission (Commission) received an application for a certificate of authority to provide interexchange telecommunications services and local exchange services within the exchanges served by Qwest Corporation from EnTelegent Solutions, Inc. (EnTelegent).

On February 26, 2009, the Commission electronically transmitted notice of the filing and the intervention deadline of March 13, 2009, to interested individuals and entities. No petitions to intervene or comments were filed and at its regularly scheduled March 24, 2009, meeting, the Commission considered EnTelegent's request for a certificate of authority. Commission Staff recommended granting a certificate of authority, subject to the condition that EnTelegent not offer any prepaid services (including prepaid calling cards) and not accept or require any deposits or advance payments without prior approval of the Commission, and subject to rural safeguards.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapter 49-31, specifically 49-31-3 and 49-31-69 and ARSD 20:10:24:02, 20:10:24:03 and 20:10:32:03. The Commission finds that EnTelegent has met the legal requirements established for the granting of a certificate of authority. EnTelegent has, in accordance with SDCL 49-31-3 and 49-31-71, demonstrated sufficient technical, financial and managerial capabilities to offer telecommunications services in South Dakota.

The Commission approves EnTelegent's application for a certificate of authority, subject to the condition that EnTelegent not offer any prepaid services (including prepaid calling cards) and not accept or require any deposits or advance payments without prior approval of the Commission, and subject to rural safeguards. The certificate of authority for EnTelegent shall authorize it to offer local exchange services in South Dakota, except in those areas served by a rural telephone company. In the future, should EnTelegent choose to provide local exchange services statewide, with respect to rural telephone companies, EnTelegent will have to come before the Commission in another proceeding before being able to provide local service in that rural service area pursuant to 47 U.S.C. § 253(f) which allows the Commission to require a company that seeks to provide service in a rural service area to meet the requirements in 47 U.S.C. § 214(e)(1) for designation as an eligible telecommunications carrier. In addition, the granting of statewide certification will not affect the exemptions, suspensions, and modifications for rural telephone companies found in 47 U.S.C. § 251(f). It is therefore

ORDERED, that EnTelegent's application for a certificate of authority to provide interexchange telecommunications services and local exchange services within the exchanges served by Qwest Corporation is granted, subject to the condition that EnTelegent not offer any prepaid services (including prepaid calling cards) and not accept or require any deposits or advance payments without prior approval of the Commission. It is

FURTHER ORDERED, that the Commission shall authorize EnTelegent to offer its local exchange services in South Dakota, except in those areas served by a rural telephone company.

FURTHER ORDERED, that this order constitutes your certificate of authority as described above.
