On October 8, 2009, the South Dakota Public Utilities Commission (Commission) received a filing from 360networks (USA) inc. (360networks) for approval of revisions to its switched access tariff sheets 1, 2, 4, 48, and 51 to 54 which address changes to the switched access rates, removes certain toll free descriptions and rates, and changes the PIC language and rates. 360networks also requests a waiver of ARSD 20:10:27:07 and requests an effective date of November 10, 2009. On November 3, 2009, the Commission received a revised tariff sheet from 360networks.

On October 15, 2009, the Commission electronically transmitted notice of the filing and the intervention deadline of October 30, 2009, to interested individuals and entities. No parties sought intervention.

At its regularly scheduled meeting of November 10, 2009, the Commission considered this matter.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31. The Commission voted unanimously to approve the above revisions to 360networks's Switched Exchange Access Telecommunications Services Tariff No. 1 and to grant a waiver of ARSD 20:10:27:07. It is therefore

ORDERED, that the Commission approves the above referenced revisions to 360networks' Switched Exchange Access Telecommunications Services Tariff No. 1 effective as of November 10, 2009. It is further

ORDERED, that the Request for Waiver of ARSD 20:10:27:07 is hereby granted.
