**ORDER APPROVING  
TARIFF AND GRANTING  
PETITION FOR WAIVER**

IntelePeer, Inc. (IntelePeer) filed on January 27, 2010, for approval of its Switched Access Service Tariff No. 1.


The Commission finds it has jurisdiction over this matter pursuant to SDCL 49-13-18, 49-31-19 and ARSD 20:10:27.

On May 14, 2010, the Commission received a request from IntelePeer for an exemption from developing company specific cost-base switched access rates per ARSD 20:10:27:11. Additionally, the company requested an exemption from the formula in ARSD 20:10:27:12; from the calculation of billing and collection costs as set forth in ARSD 20:10:27:13, and from the filing requirements set forth in ARSD 20:10:27:07. The company requests instead, for permission to mirror or cap all switched access rates and all related rates at the rate used by Qwest Corporation for the same.


The Commission considered the requests at its May 18, 2010 meetings. Commission Staff recommended approval of all switched access portions of the Switched Access Tariff No 1. Additionally, Staff recommends the Commission grant waivers from ARSD 20:10:27:12, 13 and 07 so long as switched access rates and all related switched access costs be at or below comparable Qwest Corporation rates. It is therefore

ORDERED that IntelePeer's request for an exemption from developing company specific cost-based switched access rates; request for a waiver from the formula in ARSD 20:10:27:12; from the calculation of billing and collection costs as set forth in ARSD 20:10:27:13 and the requirement set forth in ARSD 20:10:27:07 that IntelePeer file cost data in support of its switched access service tariff no less than once every three years is granted so long as IntelePeer's switched access rates and all associated costs be at or below those of Qwest Corporation's rates.
