The purpose of this filing is to incorporate the requirements of the Federal Communications Commission's Report and Order in WC Docket No. 10-90, et al., FCC No. 11-161 (released November 18, 2011) and Second Order On Reconsideration, FCC 12-47 (released April 25, 2012) regarding the treatment of VoIP-PSTN traffic.
