**ORDER APPROVING
TARIFF REVISIONS**

On December 17, 2014, the South Dakota Public Utilities Commission (Commission) received a filing from the Local Exchange Carrier Association, Inc. (LECA) requesting approval of revisions to its Access Tariff No. 1. The purpose of the filing is to update the tariff to reflect the mergers of Western Telephone Company into Venture Communications Cooperative, Inc. and RC Communications, Inc. into Roberts County Telephone Cooperative Association, and will be known as RC Technologies following the merger. On December 30, 2014, LECA filed revised tariff pages. LECA requested approval of the following tariff pages:

On December 18, 2014, the Commission electronically transmitted notice of the filing and the intervention deadline of January 2, 2015, to interested individuals and entities. No parties sought intervention.

At its regularly scheduled meeting of January 20, 2015, the Commission considered this matter. The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31. Commission staff recommended approval. The Commission voted unanimously to approve the revisions to LECA's Access Services Tariff No. 1. It is therefore

ORDERED, that the Commission approves the above-referenced revisions to LECA's Access Services Tariff No. 1 effective as of January 1, 2015.
