On May 26, 2017, the South Dakota Public Utilities Commission (Commission) received a filing from Qwest Corporation dba CenturyLink QC (CenturyLink) requesting approval of revisions to its Access Service Tariff. This filing is the sixth step in implementing the Transitional Intrastate Access Service reductions mandated by the Federal Communications Commission's November 18, 2011, Report and Order and Further Notice of Proposed Rulemaking in WC Docket Nos. 10-90, etc. (FCC 11-161). A July 1, 2017, effective date was requested.

On June 1, 2017, the Commission electronically transmitted notice of the filing and the intervention deadline of June 16, 2017, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No parties sought intervention.
