On June 19, 2017, the South Dakota Public Utilities Commission (Commission) received a filing from dishNET Wireline L.L.C. (dishNET) requesting approval of revisions to its Tariff No. 2, Sheets No. 2, 37, and 39. The proposed tariff revision filing is done in compliance with the FCC's order in FCC11-161. On June 27, 2017, DishNET made a revised filing. DishNET requests an effective date of July 1, 2017.

On June 22, 2017, the Commission electronically transmitted notice of the filing and the intervention deadline of July 7, 2017, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No parties sought intervention.

The following South Dakota P.U.C. Tariff No. 2 pages were filed for Commission approval:

At its regularly scheduled meeting of July 21, 2017, the Commission considered this matter. The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31. Commission Staff recommended approval. The Commission voted unanimously to approve the requested revisions to dishNET's South Dakota P.U.C. Tariff No. 2. It is therefore

ORDERED, that the Commission approves the above-referenced pages of dishNET's South Dakota P.U.C. Tariff No. 2, with an effective date of July 1, 2017.
