**ORDER APPROVING  
AMENDMENT TO  
INTERCONNECTION  
AGREEMENT**

**TC20-012**

On June 19, 2020, the South Dakota Public Utilities Commission (Commission) received a filing pursuant to 47 U.S.C. § 252 for approval of an Amendment to an Interconnection Agreement between Qwest Corporation dba CenturyLink QC and Spectrotel, Inc. dba OneTouch Communications dba Touch Base Communications (Spectrotel) for the State of South Dakota. The amendment incorporates forbearance orders FCC 19-66 and FCC 19-72, which were released by the Federal Communications Commission in 2019.

On June 25, 2020, the Commission electronically transmitted notice of the filing of the agreement to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. The notice stated that any person wishing to comment on the parties' request for approval had until July 9, 2020, to do so. No comments were filed.

At its regularly scheduled meeting on August 4, 2020, the Commission considered whether to approve the negotiated agreement between Qwest Corporation dba CenturyLink QC and Spectrotel Commission staff recommended approval.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31 and the Federal Telecommunications Act of 1996. In accordance with 47 U.S.C § 252(e)(2)(A), the Commission found that the Amendment to the Interconnection Agreement does not discriminate against a telecommunications carrier that is not party to the Amendment and the Amendment is consistent with the public interest, convenience, and necessity. The Commission unanimously voted to approve the Amendment to the Interconnection Agreement. It is therefore

ORDERED, that the Commission approves the Amendment to Interconnection Agreement between Qwest Corporation dba CenturyLink QC and Spectrotel.
